
The Governor of Tripura is pleased to modify the existing provisions of paras 4.2,5.1,5.2,17.3 of the Notification No.F.12(7)-GIS/08/954 dated 22nd May,2009 regarding Tripura State Government Employees Group Insurance Scheme,1983 as follows and to enhance the monthly subscription and Insurance coverage for all the 4(four) Groups of State Government Employees w.e.f. 1st March,2021.

Existing Provision(modified on 22nd May,2009)(w.e.f. 1 st March,2009)	Modified Provision (w.e.f.1 st March,2021).
<p>4.2. Those employees who were member of the 'Scheme' as on 28-02-2009 will have an option to opt out of the Scheme with subscription unit of Rs.75/- per month. This option should be exercised by 30th May, 2009.The employees who will retire from Govt. service on or before 30th June, 2009 will not be included in the modified provision.</p> <p>Those employees who do not opt out of the Scheme with subscription unit of Rs.75/- per month by that date will be deemed to have opted for the Scheme with the subscription of Rs.75/- per month w.e.f. 1st March, 2009.</p> <p>The option once exercised (or not exercised) will be treated as final and no further choice will be available</p> <p>Other employees who opted out of the modified Scheme with the subscription unit of Rs.75/- per month will not come under the modified Scheme and their membership deemed to be ceased. Total accumulation of Savings fund with existing rate of interest will be refunded accordingly.</p>	<p>4.2. Those employees who would be member of the 'Scheme' as on 28-02-2021 will have an option to opt out of the Scheme with subscription unit of Rs.150/- per month. This option should be exercised by 28th February, 2021.</p> <p>Those employees who will not opt out of the Scheme with subscription unit of Rs.150/- per month by the date will be deemed to have opted for the Scheme with the subscription of Rs.150/- per month w.e.f. 1st March, 2021.</p> <p>The option once exercised (or not exercised) will be treated as final and no further choice will be available.</p> <p>Other employees who opted out of the modified Scheme with the subscription unit of Rs.150/- per month will not come under the modified Scheme and their membership deemed to be ceased. Total accumulation of Savings fund with existing rate of interest will be refunded accordingly.</p>

<p>5.1. The subscription for the modified Scheme will be in unit of Rs.75/- per month. A Group-D employee will subscribe for 1(one) unit, a Group-C for 2(two) units, a Group-B for 3 units and a Group-A employee for 5 units. Thus, the rate of subscription for a member of the Scheme shall be Rs.75/-, Rs.150/-,Rs.225/- and Rs.375/- per month for Group-D, C, B & A respectively.</p>	<p>5.1. The subscription for the modified Scheme will be in unit of Rs.150/- per month. A Group-D employee will subscribe for 1(one) unit, a Group-C for 2(two) units, a Group-B for 3(three) units and a Group-A employee for 5(five) units. Thus, the rate of subscription for a member of the Scheme shall be Rs,150/-, Rs.300/-,Rs.450/- and Rs.750/- per month for Group-D,C,B & A respectively.</p>
<p>5.2. The amount of Insurance cover will be Rs.75,000/- for each unit of subscription. Thus, the Insurance coverage for each Group-D, C, B & A employees will be Rs.75,000/-,Rs.1,50,000/-,Rs.2,25,000/-& Rs.3,75,000/ - respectively.</p>	<p>5.2. The amount of insurance cover will be Rs.1, 50,000/- for each unit of subscription. Thus, the insurance coverage for each Group-D, C, B & A employees will be Rs.1, 50,000/-, Rs.3, 00,000/-, Rs.4,50,000/- & Rs.7,50,000/- respectively.</p>

Consequent upon revision of pay scales (Pay band) Tripura State Civil Service (Revised Pay) Rules, 2017 introduced 1st April, 2017 and Tripura State Civil Service (Revised Pay) (First Amendment) Rules, 2018 of State Government Employees and in supersession of all Memos regarding classification of Groups under Tripura State Government Employees Group Insurance Scheme, 1983 it is for information of all concerned that the following classification of employees as Group-A, Group-B, Group-C and Group-D would effect from 1st March, 2021.

Classification of Group	Pay Scale
A	The Government employees holding all posts in Pay band No.4 and HAG + scale with grade pay ranging from Rs.5400 – Rs.8700/- with Apex scale & Pay Metric level;-14-21.
B	The Government employees holding all posts in Pay band No.3 with grade pay ranging from Rs.4400- Rs.4800/-& Pay Metric level:-11-13.
C	The Government employees holding all posts in Pay band No.2 with grade pay ranging from Rs.2000- Rs.4200/-& pay Metric level ;-5-10.
D	The Government employees holding all posts in Pay band No.1 with grade pay ranging from Rs.1400 – Rs.1900/-& pay Metric level;-1-4.

The rates of subscription for the members of the Scheme will be Rs.750/-, Rs.450/-, Rs.300/- and Rs.150/- for Group- A, Group-B, Group-C and Group-D employees respectively.

MEMORANDUM

Consequent upon revision of pay scales (Pay band) of the Tripura State Government Employees under T S C S (Revised Pay) Rules, 2017 introduced 1st April, 2017 and T S C S (Revised Pay) (First Amendment) Rules, 2018, Notification was issued from this Department vide No.F12(7)-GIS/2008-09/Vol-II/2787 dated 22nd January, 2021 revising monthly subscription and insurance cover of the members of the Tripura State Government Employees Group Insurance Scheme with effect from 1st March, 2021. It is noticed that after issue of this notification, necessity has been felt to clarify the break up of revised rates of subscription relating to savings fund, insurance fund and insurance cover. Accordingly, the break up is indicated in the table below:-
