

ORDER SHEET

The Chairman and representatives of the society present today through VC were asked about their capacity and plan to repay the depositors. It was also informed to the representatives of society present today that in the recent past this Authority is receiving more than 1000 complaints a day where depositors have complained that their dues have not been paid. They were also informed that more than 34,000 complaints have been received by this Authority in the last 7-8 months which have been sent for redressal to the Society. In spite of giving number of opportunities, society has failed to redress the complaints.

2) Chairman of the Society requested that he has joined as Chairman only this year after being elected and he has not got an opportunity to structure the administration of the society properly. Chairman has also sought six months' time to set the house in order. When asked about the resolution plan as well as the method of building confidence among the depositors, the representatives could not give satisfactory reply.

3) It was also pointed out by this Authority that Sahara group has published an advertisement recently in which they have themselves admitted that the payment of depositors including cooperatives is being delayed. The publication of advertisement and the statement made by the representative today is contradictory and therefore their submissions before this Authority cannot be relied upon.

4) This Authority has issued a letter to Ministry of Corporate Affairs for investigating the investments made in various companies by this Cooperative society. Considering the present scenario, it is very important that the investigation be completed quickly so that the trust of depositors can be safeguarded. Director (Cooperation) is directed to send a letter to Secretary, Ministry of Corporate Affairs and Director, SFIO for expediting the process of investigation as already requested by this Authority. In the meantime the prohibition order against the society for taking any new deposits from the existing or new members shall continue to have operation. It is further directed that Society cannot renew any deposits as well, and shall make prompt payment to the depositors/members on the date of maturity.

5) It has been observed that in spite of repeated instructions of this Authority, the society has failed to submit a plan for liquidation of its investment and bringing in the funds to

repay the depositors. The Chairman and representatives of the Society present today are directed to submit a credible plan for arranging the funds for society's regular functioning. In case the Management fails to provide a clear path for continuation of the society than this Authority will be left with no option but to initiate proceedings under Section 86 of the Multi-state Cooperative Societies Act, 2002.

6) Case is fixed for next hearing on 06.11.2020 at 3.00 p.m.


